General Bids will be received until **26 July 2024 on 10:00AM EDT** and publicly opened online, forthwith.

Filed Sub-bids for the trades listed below will be received until **NULL on NULL** and publicly opened online, forthwith.

Filed sub-bidders must be DCAMM certified for the trades listed below and bidders must include a current DCAMM Sub-Bidder Certificate of Eligibility and a signed DCAMM Sub-Bidder's Update Statement.
